IN CONSIDERATION of being permitted to practice, compete, officiate, observe, work for, or participate in any way in an official or unofficial organized or unorganized PRACTICE, or EVENT(S) or being permitted to enter for any purpose any RESTRICTED AREAS (defined as any area requiring special authorization such as but not limited to the Snake River Karters asphalt track and grounds, credentials, or permission to enter any area to which admission by the general public is restricted or prohibited), THE UNDERSIGNED, for themselves, personal representatives, heirs, and next of kin:

Acknowledges, agrees, and represents that I/we have or will immediately or upon entering any of such RESTRICTED AREAS (such as but not limited to the Snake River Karters asphalt track and grounds), which I/we enters and I/we further agrees and warrants that, if at any time, I/we is in or about RESTRICTED AREAS (such as but not limited to the Snake River Karters asphalt track and grounds) and feels anything to be unsafe, I/we will immediately advise the Snake River Karters officials of such and will leave the RESTRICTED AREAS (such as but not limited to the Snake River Karters asphalt track) and/or refuse to participate further in the PRACTICE, or the EVENT(S).
